



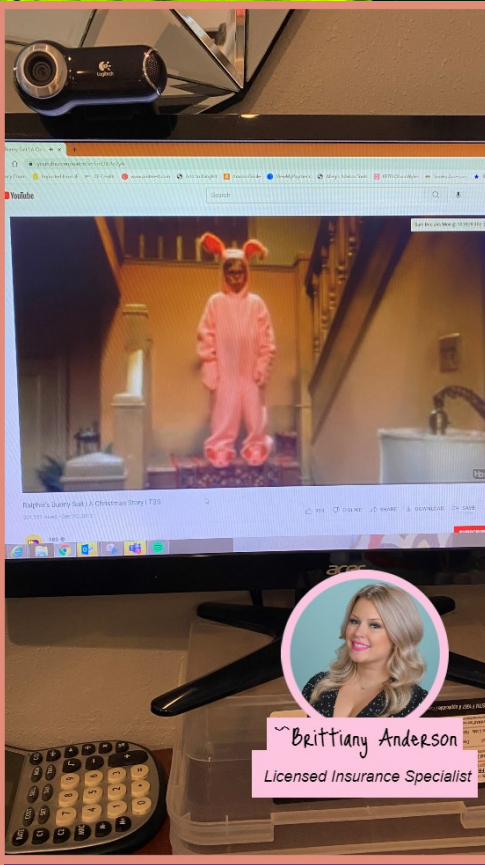

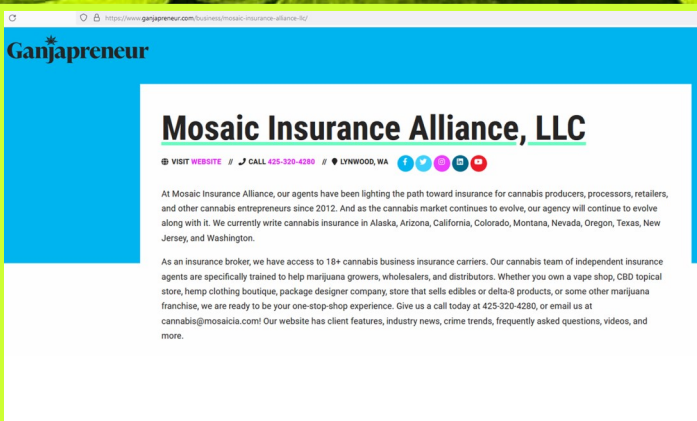
He then said that he definitely was calling the cops. She said that she needed to go find her cellphone and get her insurance card.

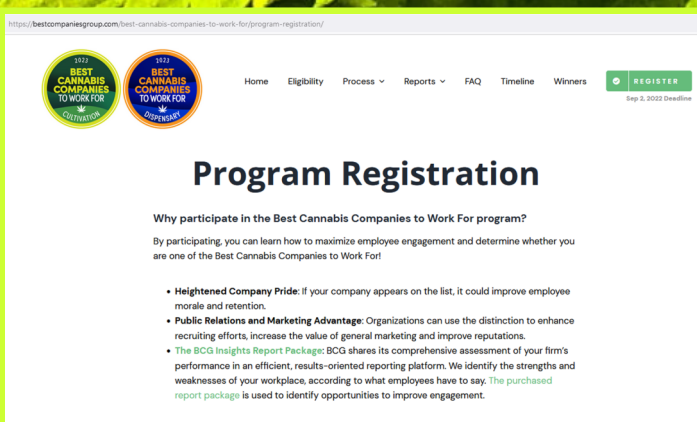

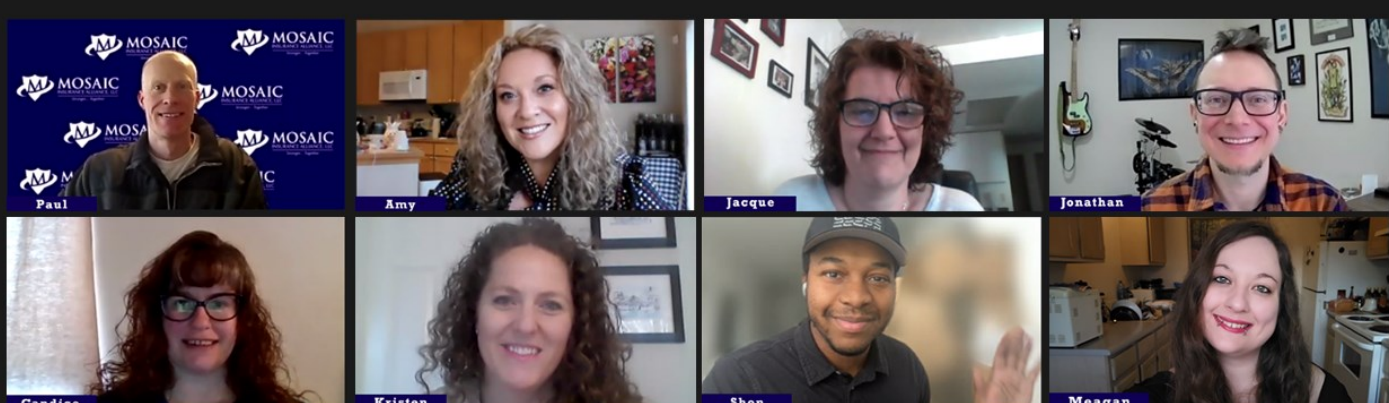
